### Illinois Department of Public Health Update

- Karen Senger (IDPH) presented as of August 2021 (84 Treatment Facilities), down from 85 due to
  on facility transferred to treatment of adolescences, adults, and transfer pediatrics. Treatment
  w/APT reduced from 52 to 48 (transitioned to Transfer facilities); Transfer facilities increased
  from 49 to 54. Still have 2 out-of- State (Indiana, Wisconsin). There is interest in the St. Louis
  Area.
- FQHC's Extended to end of the year; they are in compliance; 19 individuals present; 11 kits offered; 3 kits completed (not a full 6 months of data)
- January to June 2051 kits offered (all ages)
- Increase in pediatric kit completion rates 75%
- Surveys: 10 complaints (all above I80); new surveys to be distributed in the next 6 months (Instate site surveys will be announced)
- Administrative Rules Update: Recommended changes to survivor in custody, a qualified medical provider can request for law enforcement to remain in room as necessary but still give privacy to survivor.
- What to do when patient declines to be transferred: The following has been added to the rules STDs, HIV and Pregnancy (criminal identification act)

- Detailed Summary of Trainings Offered 2018 2021
  - July 21<sup>st</sup> Virtual Training Adult/Adolescent; 55 participants accepted; 50 attended; 6 No Show/Cancellations
  - Since 2018, 1028 AA accepted to the program, 827 have attended, 201 No Show/Cancellations.
  - No updates to the Pediatric data (last reviewed in June Meeting)
  - State of IL AA SANE Trained 2021 (129); State of IL Completion 2021 (41) number subject to increase; No changes to national certification numbers, 377 practicing AA SANEs, 33 Trained Pediatric SANEs, 11 new practicing PA, 5 nationally certified pediatric SANE's, anticipated 7-8 new PA SANEs.

## Legislative Updates/Illinois Hospital Assoc. (House Bill 1739/Public Act 102-0022)

- Beginning January 1, 2022, a treatment hospital, with approved pediatric transfer, or an approved pediatric health care facility must notify sexual assault survivors in writing about the Illinois State Police sexual assault evidence tracking system.
- Beginning January 1, 2022, when sexual assault evidence is collected from a survivor, the
  Healthcare provider or law enforcement officer who collects the evidence must notify the
  Survivor about the tracking system.
- Beginning January 1, 2023 (pushed back 1 year from 2022) QMP Mandate, outlined in 410 ILCS 70 (PA 100-0775) requiring all treatment hospitals and treatment hospitals with approved pediatric transfer to have a Qualified Medical Provider available to provide a medical forensic exam within 90 minutes of patient arrival.
- Deleting the January 1, 2022 sunset of a provision in current law allowing an adult survivor to be transferred to the closest treatment hospital, regardless of whether that hospital also treats pediatric patients. As a result, adult survivors can continue to be transferred to the closest treatment hospital.
- Extending by six months, to December 31, 2021, a current provision allowing federally qualified health centers (FQHC) to complete a sexual assault treatment plan to be approved by the Illinois Department of Public Health. This would enable an approved FQHC to provide medical forensic services to sexual assault survivors.

- Urban Areawide Treatment Treatment Plan Subcommittee
  - Will meet with the subcommittee for a status update on the 3 current pediatric
    hospitals (Advocate Children's Hospital Oak Lawn, Advocate Children's Hospital Park
    Ridge, Ann & Robert H. Lurie Children's Hospital of Chicago) acceptance of pediatric
    transfers. Follow-up to include Stroger Hospital regarding their acceptance of pediatric
    patients.
- Rural Areawide Treatment Plan Subcommittee
  - (Katie Gossett) SIH Accepting patients; Harrisburg Hospital joining the SIH system, will be transitioning them to an SIH treatment facility; working on transfer/transportation agreement with area 10 hospitals; changing SANE staffing model from on-call to full time (scheduled to be finalized March/April 2022) at that time will be able to accept both adult and pediatric transfers. How can the taskforce assist: Need nurses to complete pediatric check-offs, no facilities nearby to provide training. Need more SANE trained nurses in area.
  - (Mindy Robles) Northwestern Medicine Kishwaukee Hospital; 2 hospitals to remain pediatric treatment centers, partnering with MERITI to provide 24hr pediatric coverage, assisting with acute cases and case review; all 4 will be Adult/Adolescent treatment centers; receive transfer patients from Valley West to Kishwaukee. Surrounding hospitals inquiring about collaborating with Northwestern, program new will follow-up in the near future.
  - O (Sue Drabing) MEDS Program; AA services going extremely well, turn-around-time is approximately 3 months for clinical completion; 4 nurses completed pediatric training; have found some nurses reluctant to treat pediatric patients; for the month of August expected to see 260-270 AA cases (treatment or transfer); approached by hospitals on the east and west St. Louis Metro area boundaries to be their pediatric treatment facilities, approval pending; a few facilities are hesitant to dispense HIV drugs to victims; Need Taskforce assistance with recruitment and training of pediatric nurses; Approaching 1 year anniversary/added coordinator.
  - o (Kaylie Gilbert) Working with Western Illinois University on several initiatives:
    - Start by Believing Campaign with local Rape Crisis Center, Title IX Coordinator,
       Campus Security and Campus Public Relations Dept.
    - Rural SART Meeting; Collaborated with Nursing Department to host simulation
       Lab
    - Partnered with Frontline Forensics (Employment & Training) for SANE Nurses
